ONBOARDING EVENTS TIMELINE



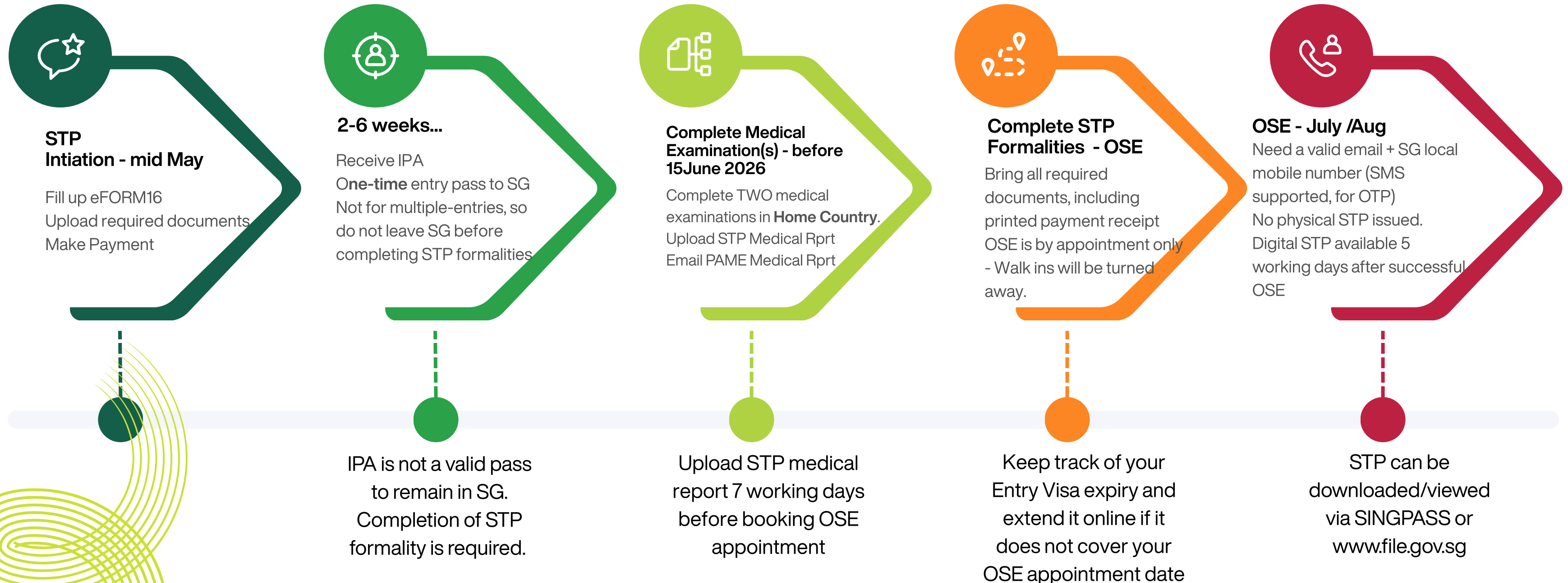


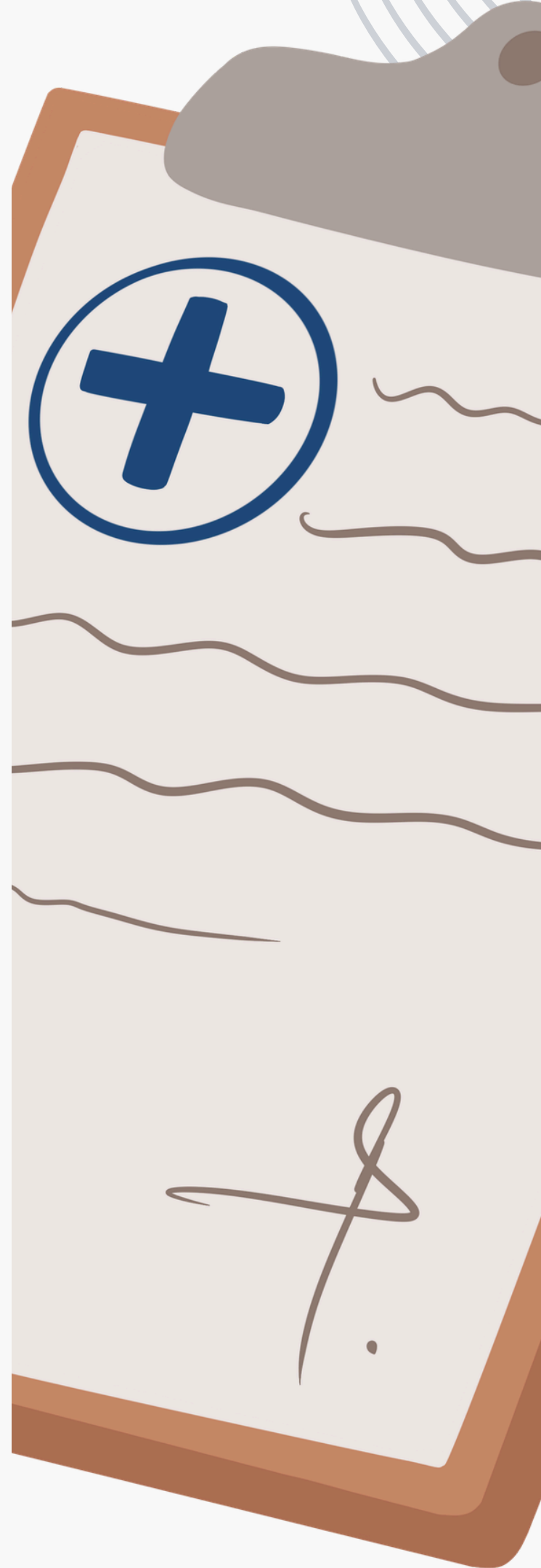
Student Pass Application

- Initiated by University in mid-May
- Use a current/valid email address in your STP application (eFORM16)
- Students need to complete STP formalities at On-Campus STP Exercise (OSE) to obtain Student Visa
- OSE Dates (UTown, Multi-Purpose Hall 2, process takes approx. 1 hr):
 - July - 24, 27-31
 - August - 4, 21, 24, 25
- OSE can only be booked **after** all STP document submission and fee payment are completed (including medical examination report)
- Please upload medical examination report at least 7 working days before OSE booking. Students are to complete ICA medical examination **in your home country**.
- A local SG mobile number is **mandatory** to complete STP formalities. Please register for your personal local SG mobile number **before** attending the OSE
- **PLEASE EXTEND Entry Pass if it expires before your completion of STP formalities [HERE](#)**. Overstaying is a punishable offence in Singapore



Student Visa Application Summary





Medical Examination(s) (STP & NUS PAME)

MEDICAL ALERT

Complete ICA Medical Examination in your **Home Country**

- Use ICA's Medical Examination Form
- Medical records must bear your Name, Date of Birth, and ID
- Medical form stamped & signed by Doctor, completed in English
- Upload to ICA at least 7 days before OSE appointment booking.
- Medical report has a 3 month validity.

NUS Pre-Admission Medical Examination

- Complete both STP and PAME medical examinations together in your **Home Country**.
- Use PAME Medical Examination Form
- Email completed medical report to preadm_med@nus.edu.sg
- Only medical reports completed after 1 Feb 2026 can be submitted.
- Deadline for submission: **7 Aug 2026**
- Can be done at University Health Centre (UHC) by **appointment only**
- Negative Service Indicator (NSI) implications



Spouse &/or Child: Long Term Social Visit Pass (LTSVP)

- Accompanying spouse/children below age 17 (excl. parents) of STP holders may apply for a Long Term Social Visit Pass after arriving in Singapore.
- Application for LTSVP can only be done **AFTER** student completes STP formalities and obtained digital STP.
- Refer to instructions from Admissions Portal
- Applicants will have to make an appointment at ICA to complete formalities for LTSVP application in person, within the validity of the entry stamp on passport.
- Student/STP holder has responsibility to ensure their spouse/child has a valid pass in SG at all times.
- A copy of the marriage/child's birth certificate as applicable
- A copy of the insurance policy for hospitalization and personal accident coverage of each spouse or child to be sponsored



Student Insurance

- Mandatory for all Full-Time international students: valid 1 month prior to matriculation date or upon arrival in Singapore, whichever is later
- Provides all full-time students with basic medical and personal accident insurance coverage
- Basic healthcare fees are charged to your miscellaneous student fees and due at the same time as your tuition fees. This is a compulsory scheme with no available opt-out option.
- Charged for every semester you remain on campus
- Benefits will cease when you are on Leave of Absence (LOA), converted to a Part Time basis, or have withdrawn from the programme. Paid premiums are non-refundable.

Welcome Email From Office of the Registrar

- Look out for NUS Welcome Email from 8th June onwards.
- Click on personalised link to Check-In page with your Application ID populated
- Officially become an NUS Student upon completion of Check-In & Onboarding
- Use only **laptop/desktop** to complete this task

Complete BOTH Check-In AND Onboarding

- **Check-in:** Obtain NUS-ID & PW, Upload Photo, submit declarations.
- **Onboarding:** Verify academic/personal information & declarations.
- Allow 12 hours after completion for your NUS accesses to be activated.
- Follow the instruction guide closely.

Upload & Verify Photo

- Choose a clear headshot/passport sized photo without sunglasses or headgear

Complete 2 e-Learning Modules on NUS Canvas

- MBA course registration is only possible **AFTER** the completion of the two e-learning modules.



Important Points to Note:

- Contact NUS IT Support - **itcare@nus.edu.sg** if you encounter technical issues/errors with your Check-In & Onboarding process
- Check your spam/junk box if you do not receive your NUS Welcome Email
- Use only laptop/desktop to complete these processes
- Complete your Check-in/Onboarding latest by **27 June 2026**
- Note your NUS ID/PW created, to access all NUS platforms.

Use Singpass to reduce the number of documents to submit!



Application with Singpass

1. Identification Document

- For Singaporeans/Permanent Residents, not required
- For Malaysians, front & back of Malaysian IC
- For Other nationalities, Passport biodata page

2. Additional Documents*:

- **Document with Residential Address** (*needed only if not using address stated in Myinfo)
- **Proof of Tax Residency** (*needed only if tax residency outside of Singapore)
- **Proof of Mobile number Ownership** (*needed only if mobile number already exists in the bank's record)

Application without Singpass

1. Identification Document

- For Malaysians, front & back of Malaysian IC
- For Other nationalities, Passport biodata page

2. Singapore-issued Pass

- Card or digital IC (Student's Pass, Dependant's Pass, etc), **OR**
- In-Principle Approval (IPA) letter from ICA

3. Document with Residential Address

- School Certification Letter, **OR**
- Utility / Mobile Phone Bill under your name

4. Proof of Tax Residency

- For Singapore Tax Residency
 - digital IC, **OR** In-Principle Approval (IPA) letter from ICA
- For other country/jurisdictions
 - Passport biodata page, **OR** National ID Card, **OR**
 - Others (residence permit/birth cert/ government-issued documents from tax authority showing recent filing of income tax)

5. Proof of Mobile Ownership (if mobile number already exists in the bank's record)

- Certification letter from your Telco provider

Note

School letterhead, signature & authority stamps must be included, with Full Name & Residential Address tallying with your application details.

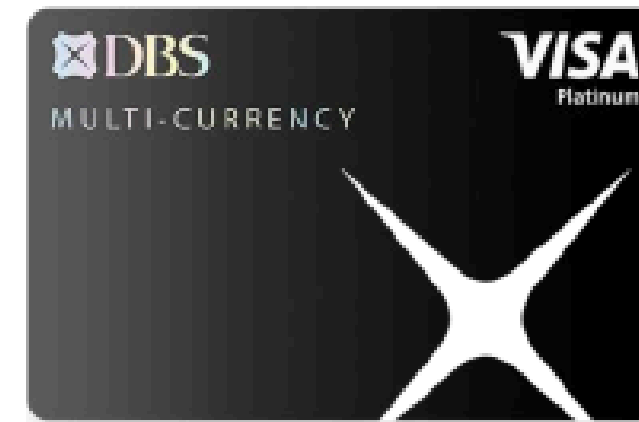

- a. Download **digibank app** on your mobile.

Account Opening **without using Singpass**



1. Download digibank app
2. Select "**CONTINUE WITHOUT SINGPASS**" option
3. Input all required details
4. Upload all [supporting documents](#)

Your application will be processed within 3-5 working days.

If additional document or information is required, you will receive a follow up email.

Activate your Debit Card via SMS Banking or DBS/POSB ATM

Once your application is approved, your debit card will be mailed to your residential address within 3-4 working days.

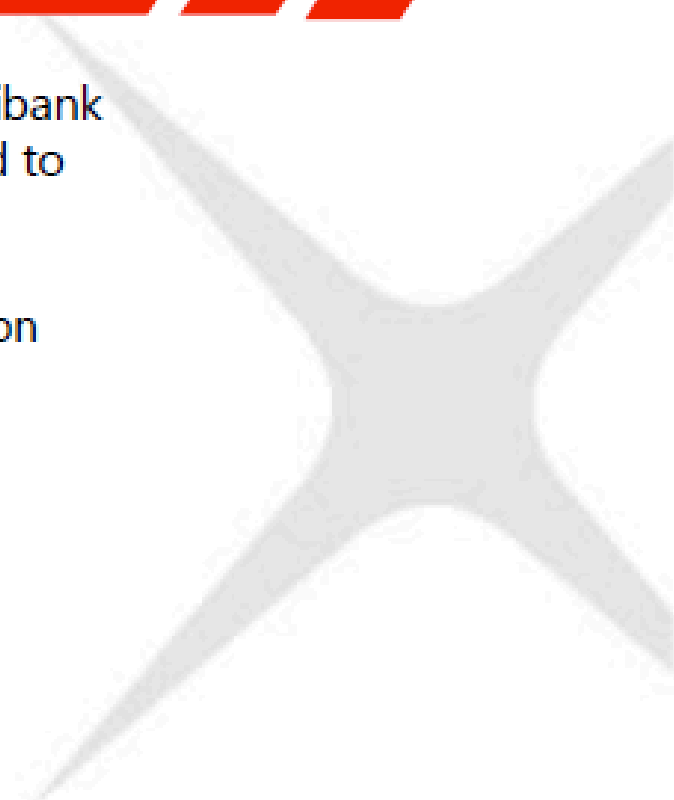
