
#### **PEKING UNIVERSITY | GUANGHUA SCHOOL OF MANAGEMENT (PKU)**

- Minimum 2 years of post-bachelor's full-time work experience
- Good GMAT/GRE score
- TOEFL score  $\geq$ 100 or IELTS score  $\geq$ 6.5 (if the medium of instruction during undergraduate studies was not English)

The Chinese Common Entrance Examination is required for applicants who are holding a PRC Chinese passport.

Interested applicants are required to submit online applications to **both** NUS Business School and Guanghua School of Management respectively.
